

PRIVACY STATEMENT - BRUGKREDIET B.V.

Brugkrediet B.V. respects your privacy and attaches great importance to the careful handling of your personal data. This privacy statement explains which personal data we process, for what purpose, on what legal grounds, and what rights you have.

Article 1 – Definitions

- **Website:** the Brugkrediet website, accessible via www.bridgeloan.nl.
- **Controller:** Brugkrediet B.V., located at Willem de Zwijgerlaan 35, 1056 JE Amsterdam.

Article 2 – Scope

This privacy statement applies to all services that Brugkrediet offers via its website, as well as to the processing of personal data in that context.

Article 3 – Collection and Processing of Personal Data

Brugkrediet only processes personal data for legitimate purposes, including:

- Maintaining contact;
- Processing service requests;
- Complying with legal obligations.

Data we may process includes:

- Name, address, and contact details;
- Financially relevant information for assessing your request;
- Technical data such as IP address and cookies (see Article 9).

Article 4 – Legal Grounds for Processing

We only process your personal data based on one or more of the following legal grounds:

- Performance of a contract;
- Your explicit consent;
- Compliance with a legal obligation;
- Our legitimate interest, such as improving our services.

Article 5 – Retention Periods

We do not retain your personal data longer than necessary for the purpose for which it was collected, unless a legal retention obligation applies.

Article 6 – Your Rights

You have the following rights regarding your personal data:

- Access;
- Correction of incorrect data;
- Deletion (right to be forgotten);
- Restriction of processing;
- Objection to processing;
- Data portability.

You can exercise these rights by contacting us via info@bridgeloan.nl. For verification, we may request a copy of a valid ID.

Article 7 – Sharing of Data

We only share your personal data with third parties if necessary for the performance of our services or to comply with legal obligations. We enter into appropriate data processing agreements with processors to safeguard your privacy.

Article 8 – Security

Brugkrediet takes appropriate technical and organizational measures to protect your personal data against loss, unauthorized access, or unlawful processing.

Article 9 – Cookies

Our website uses cookies to optimize functionality and user experience. We use:

- **Functional cookies:** necessary for the proper functioning of the website;
- **Analytical cookies:** provide insight into website usage (anonymized).
